Containing 2.23 acres, more or less.

WHEREAS, there is no well situated on said above described property, and WHEREAS, party of the first part is the owner of contiguous land upon which there is situated a well of water, which well of water is situated 200 feet South of the Autrey and Patricia Sewell house, situated on the above described property, and

WHEREAS, parties hereto are desirous of securing to the owners of the above described property the right to obtain water from the well situated on the property of party of the first part, and the right to install, repair and maintain a water pipe or water pipes to said well:

NOW, THEREFORE, in consideration of the premises and the sum of One and no/100 (\$1.00) Dollars to party of the first part, in hand paid by party of the second part, the receipt of which is acknowledged, party of the first part does hereby grant unto party of the second part, their heirs and assigns, the right to take and use water from said well for the above described lot, in common with the owners of the property now owned by party of the first part, their heirs and assigns. Party of the second part shall further have the right and privilege, together with party of the first part and such other persons as may be designated by party of the first part, to connect to the pump now located at said well, and to lay water pipes over and across a strip of land five feet wide measuring 2½ feet on either side of a center line described as follows:

Beginning at the Well of party of the first part, which well is located 200 feet South of the Autrey and Patricia Sewell house, situated on the above described property, and extending North to the above described property as said pipeline is now located.

It is agreed and understood that as a part of the consideration for the grant of this easement and water right, party of the second part, their heirs and assigns, assume and agree to pay the entire cost of electricity and cost of maintaining, repairing and/or replacing said pump.
