Hughes & Geneva Hughes, recorded in Book 305, Page 390, of the land mortgage records of Shelby County, Alabama, does hereby release from said mortgage (deed of trust) the following:

A part of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Sec. 7, Twp. 21, Range 1 East, described as beginning at a point on the West line of said Columbiana and Wilsonville Highway about 50 feet West of the Northeast corner of said forty acres and running Southwesterly along said highway 402 feet to the point of beginning; thence northwesterly, north 40 deg. west 365 feet, more or less, to a point on the north line of said forty acres; thence west along the north line of said forty 518 feet to a small branch; thence southerly along the meanderings of said branch (crossing the Chelsea Road) about 700 feet to the northwest line of said highway; thence northeast along said highway 650 feet more or less to the point of beginning. Excepting 7/8 of an acre conveyed to the Trustees of Bethel Church.
