KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Eight Thousand (\$8,000.00) and No/100 DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEEES herein, the receipt whereof is acknowledged, we, Joe F. Wideman & wife, Myrtis F. Wideman and William Earl Richards & wife, Frances Richards (who is one & the same as Frances K. Richards) (herein referred to as grantors) do grant, bargain, sell and convey unto

Greer C. Sims and wife, Joan C. Sims

(herein referred to as GRANTEEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in

Shelby County, Alabama to-wit:

The SE-1/4 of NE-1/4 of Section 4, Township 22 South, Range 1 West, EXCEPT the following described parcel: Commence at the SW corner of said 1/4-1/4 Section and run North along West line a distance of 450 feet to point of beginning of said EXCEPTION; thence continue North along West line of said 1/4-1/4 Section a distance of 624 feet; thence run East and parallel with South line of said 1/4-1/4 Section a distance of 420 feet; thence run South and parallel with West line of said 1/4-1/4 Section a distance of 624 feet; thence run Westerly direction 420 feet to point of beginning of said EXCEPTION.
