RIGHT-OF-WAY DEED FOR PUBLIC ROAD

receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be
feet in width on each said
road, as it is now located and staked out by the Highway Department or as much of our lands as is required to

particularly described as follows, to-wit: And as shown on the right-of-way map of Project No. APP-14 as recorded in the office of the Judge of Prolate of Shelby County.

Commence at the northwest corner of SWs of NWs, Sec. 21, T 24 N, R 15 E, thence S 19 18 W a distance 523.84 feet to a point on the centerline of the proposed new road; thence northeasterly, along said centerline, along a 70 curve to the left (having a radius of 819.02 feet) a distance 129.0 feet to a point; thence continue along centerline of the said new road N 77 17 E a distance 452.1 feet to a point (being the point of curvature of a curve); thence northeasterly, along said centerline, along a 6 curve to the left (having a radius of 955.37 feet) a distance 564.2 feet to a point (being the end of curvature); thence N 43 26 E along the said centerline a distance 67.9 feet to the point of ending where said point joins the old existing county road.
