My name is Wilma A. Harris. I reside at Vincent, Shelby County, Alabama.

I am the widow of Barto C. Harris.

Jimmie Harris Milam, who was the wife of Paul L. Milam, is now deceased, having been killed as the result of an automobile accident on or about November 2, 1968. Said Jimmie Harris Milam was the daughter of my late husband.

I have been familiar with the ownership and possession of the NE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 5, Township 19 South, Range 2 East, Shelby County, Alabama, for the past 48 years, having recently received a conveyance to said property from said Paul L. Milam. The said deed was a deed of correction, I having given said Paul L. Milam a deed of correction to the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 15, Township 19 South, Range 2 East in exchange for said deed which he gave me. The error occurred several years ago as the result of a mistake in the description contained in a deed, the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 15, Township 19 South, Range 2 East, having been intended to have been conveyed to said Jimmie Harris Milam, but instead, said deed or deeds to said Jimmie Harris Milam containing the erroneous description, the NE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 15, Township 19 South, Range 2 East.

It has been called to my attention that W. C. Raley and wife, Mary Sims Raley, executed a mortgage on or about June 25, 1941, said mortgage describing the NE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 15, Township 19 South, Range 2 East, together with other property. Said description contained in said mortgage was evidently erroneous, as neither said W. C. Raley nor his wife, Mary Sims Raley, have

over owned, claimed, or possessed said NE¼ of SW¼ of Section 15,
Township 19 South, Range 2 East. Mr. and Mrs. Raley's property
was situated at another location.
