That in consideration of Six Thousand and no/100----- DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Ruth Houlditch, a widow; Jamie D. Houlditch and wife, Dottie L. Houlditch; and Charles Houlditch and wife, Frances Houlditch, being with grantee the sole and surviving heirs (herein referred to as grantors) do grant, bargain, sell and convey unto at law of Grady P. Houlditch, deceased

Grady H. Houlditch, Jr. and Patricia S. Houlditch

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

A tract or parcel of land situated in the SW<sub>4</sub> of the NE<sub>4</sub> of Section 3, Township 24, Range 12 East, more particularly described as follows: Commence at a point in the town of Montevallo where the eastern boundary of Gardner Street intersects the southern boundary of the Montevallo and Calera Highway and run south along the eastern boundary of said Gardner Street 400 feet; thence run east and parallel with said Highway 150 feet to the point of beginning of the lot herein conveyed; thence north and perpendicular to said Highway 100 feet; thence east and parallel to said Highway 150 feet; thence south and perpendicular to said Highway to a point 100 feet north of the south boundary of said SW<sub>4</sub> of NE<sub>4</sub> of Section 3, being the northeast corner of a lot heretofore sold to W.
