do grant, bargain, sell and convey unto the said J. B. Harless and wife Betty Jo Harless

as joint tenants, with right of survivorship, the following described real estate; situated in

Shelby County, Alabama, to-wit:

From the northwest corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 16, Township 21 South, Range 3 West run easterly along the north boundary line of said NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Sec. 16, Tsp. 21 S., R. 3 W. for 686.7 feet; Thence turn an angle of 88 degrees, 56 minutes, 10 seconds to the right and run southerly for 329.07 feet to a point on the south Right of Way line of County Road No. 26 for the point of beginning of the land herein described; Thence turn an angle of 93 degrees, 05 minutes, 30 seconds to the right and run northwesterly along the south R.O.W. line of County Road No. 26 for 117.0 feet; Thence turn an angle of 04 degrees, 52 minutes, 15 seconds to the left and continue westerly along the south R.O.W. line of said County Road No. 26 for 100.0 feet; Thence turn an angle of 91 degrees, 32 minutes, 30 seconds to the left and run southerly 363.71 feet; Thence turn an angle of 89 degrees to the left and run easterly 215.89 feet; Thence turn an angle of 90 degrees, 54 minutes, 45 seconds to the left and run northwesterly 351.44 feet, more or less, to the point of beginning.

This land being a part of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 16, Township 21 South, Range 3 West and being 1.776 acres, more or less.

TO HAVE AND TO HOLD Unto the said J. B. Harless and wife Betty Jo Harless

as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances;

that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs, and assigns forever against the lawful claims of all persons.
