

## STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Two Thousand and no/100 Dollars to the undersigned grantor or grantors in hand paid by the GRANTEE herein, the receipt whereof is acknowledged, we, Hazel Williams and husband, Lonnie Williams, Annie B. Duncan and husband, Freeman Duncan, Daisy Jackson and husband, Clint Jackson, Lee Byers Harris and wife, Rosa Harris, Lucille Hayman and husband, Jerry Hayman, Alice Fountaine and husband, Nathaniel Fountaine, Marjorie Hardaway and husband, Percy Hardaway and Barbara Bennett and husband, Charles Bennett (herein referred to as grantors) do grant, bargain, sell and convey unto Alyce Lucille Tolbert (herein referred to as GRANTEE) the following described real estate situated in Shelby County, Alabama, to-wit:

A part of the NE $\frac{1}{4}$  of NW $\frac{1}{4}$ , Section 12, Township 21 South, Range 3 West, more particularly described as follows:

Beginning at a point of East right of way line of old Birmingham-Montgomery Highway, where the north line of lands formerly known as Bradford Baker lands intersects the East right of way line of said highway, and run thence in a northerly direction along the East right of way line of said highway 296 feet to a point, which point is a SW corner of a lot formerly owned by Daisy Harris; thence run in a easterly direction along South line of said lot formerly owned by Daisy Harris to the West right of way line of Federal Highway #65; thence in a southerly direction along the west right of way line of said Highway #65 to the North line of Bradford Baker track of land which point is 150 yards more or less North of the South line of said  $\frac{1}{4} \times \frac{1}{4}$  Section; thence run westerly along North line of Baker line to point of beginning.
