Know All Men by These Presents,
That in consideration of Twenty-Two Thousand (\$22,000.00) and no/100----- DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged we, Jasper C. Glass and wife, Anne Crowe Glass (herein referred to as grantors) do grant, bargain, sell and convey unto George Frost and Iris Frost
