Joseph, the receipt whereof is acknowledged we the said Frank Coe, a widower, and Nina Belle Seay, a widow, do grant, bargain, sell and convey unto the said Joe J. Joseph the following described real estate, situated in Shelby County, Alabama, to-wit:

Part of the NW $\frac{1}{4}$ and part of the NE $\frac{1}{4}$ of Section 20. Township 21 Range 2 West, being more particularly described as follows: Beginning 888.5 feet North of the SW corner of the SE_4^1 of NW_4^1 of said Section 20, thence Easterly along the North line of the property conveyed to Wyatt by deed recorded in Deed Book 174, Page 277 in the Probate Office of Shelby County, Alabama, a distance of 1325 feet, more or less to the East line of the SE $\frac{1}{4}$ of NW $\frac{1}{4}$; thence Northerly along the East line of said SE $\frac{1}{4}$ of NW $\frac{1}{4}$. a distance of 328.4 feet, more or less, to the NE corner of said $\frac{1}{4}$ - $\frac{1}{4}$ section; thence Northerly along the East line of the NE $\frac{1}{4}$ of NW for a distance of 175 feet to the Northwest corner of the tract conveyed to J.
