My name is B. E. McClannahan and I am 88 years of age. I have all along been familiar with the following described land and thepersons in possession of it. Said land being described as follows:

A part of the Swi of Section 36, Township 21 South, Range 1 West, described as follows: Begin at the southwest corner of said Section 36 and run north along the west boundary of said Section 1709 feet; thence run east and parallel with south line of said Section a distance of 1345 feet, more or less, to west right of way line of L & N Railroad; thence run in a southeasterly direction along the west right of way line of said Railroad to the south line of said Section 36; thence run west along the south line of said Section 36 to the point of beginning; being situated in Shelby County, Alabama.

It has been common knowledge in our community that the above land, along with other property was purchased by Een Nelson in 1871. The children of Ren Nelson were: A. D. Nelson, E. J. Nelson, L. E. Helson, Daisy Glenn and Elisha Nelson; that Enthy Nelson was his widow and Adolphus Wallace was the son of Daisy Glenn and a graddson of Ben Nelson. It was also common knowledge in the community that all of said heirs mortgaged their interest in said land to Dock or A. D. Nolson and could not pay for it and A. D. Helson took said land over as his own and his heirs were the absolute owners and were in control of the land continuously after that time for some 60 years and up to the present time. Affiant further says that it is his information that Elisha Nelson did not own or claim any interest in said land after A. D. Nelson took it over as mentioned above, but after A. D. Nelson died, his widow, Pearl Nelson, let Elisha Nelson live on pert of said land and it was assessed to him, but he did not own or claim to own said land. 'Affiant says he married more than 50 years ago and said A. D. Nelson was in possession of the property at that time. Affiant says A. D.
