

Before me, the undersigned authority, in and for said County and State,
personally appeared Preston Moore
who, being known to me and being by me first duly sworn, deposes and says as
follows:

That he is 59 years of age and presently resides at Shelby
Dounty, Alabama; that he has been acquainted with the occupation, use
and possession of the following described property for the last past 30 years:

A lot in the SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sec. 32, Township 19 South, Range 1 East, Shelby
County, Alabama described as follows: Begin at the SE corner of SW $\frac{1}{4}$ of SE $\frac{1}{4}$
of Section 32, Township 19 South, Range 1 East; thence run West, along the South
line of said Section a distance of 354.13 feet to East right of way line of a
paved County Highway; thence turn an angle of 99 deg. 00 min. to the right
and run along said right of way line a distance of 151.70 feet; thence turn an
angle of 80 deg. 58 min. to the right and run a distance of 329.36 feet to East
line of said Quarter Quarter Section; thence turn an angle of 89 deg. 38 min.
to the right and run South along East line of said Quarter Quarter Section a
distance of 150.00 feet to point of beginning. Situated in SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of
Section 32, Township 19 South, Range 1 East, Shelby County, Alabama according
to survey of Frank W. Wheeler, Registered Land Surveyor, dated June 24, 1969.

At the time affiant first knew this land it was owned by L. H. Bentley whose
wife is Almeda Bentley. The land under fence and I recall that the fence was
apparently an old fence at that time. It was generally reputed in the community
to be the property of L. H. Bentley who cultivated part of the land. At times
he used it for pasture along with other lands which he owned. Affiant knows of
his own knowledge that during the time he has known the land, it has been under
fence continuously by the present owners and their predecessors in title for
more than 30 years and they have been in the actual, hostile, open, notorious,
exclusive, continuous and adverse possession of the property for more than 30
years.
