Before me, the undersigned authority, in and for said County and State,
personally appeared H. W. Maske
who, being known to me and being by me first duly sworn, deposes and says as
follows:

That he is 49 years of age and presently resides at Route,
Wilsonville, Alabama; that he has been acquainted with the occupation, use
and possession of the following described property for the last past 20 years:

A lot in the SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sec. 32, Township 19 South, Range 1 East, Shelby County, Alabama described as follows: Begin at the SE corner of SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 32, Township 19 South, Range 1 East; thence run West, along the South line of said Section a distance of 354.13 feet to East right of way line of a paved County Highway; thence turn an angle of 99 deg. 00 min. to the right and run along said right of way line a distance of 151.70 feet; thence turn an angle of 80 deg. 58' to the right and run a distance of 329.36 feet to East line of said Quarter Quarter Section; thence turn an angle of 89 deg. 38' to the right and run South along East line of said Quarter Quarter Section a distance of 150.00 feet to point of beginning. Situated in SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 32, Township 19 South, Range 1 East, Shelby County, Alabama, according to survey of Frank W. Wheeler, Registered Land Surveyor, dated June 24, 1969.

At the time affiant first knew this land it was owned by L. H. Bentley whose wife is Almeda Bentley. Affiant purchased the land from Mr. L. H. Bentley and his wife on the 6th day of December, 1951. The time he has known the land there has been no dispute as to the title or land lines, of any kind. The land has been under fence continuously by affiant and his predecessors in title for well over 20 years, and affiant and his predecessors in title have been in the actual, hostile, open, notorious, exclusive, continuous and adverse possession of the property for more than 20 years.

When affiant purchased this land in 1951 he made a diligent search at that time for some knowledge as to some persons who previously owned the land by the name of Kate O'Farrell or an A. H. O'Farrell, and affiant has heard, by rumor, that these persons left the State of Alabama more than 40 years ago and have not been heard of by anyone in this area since that time.

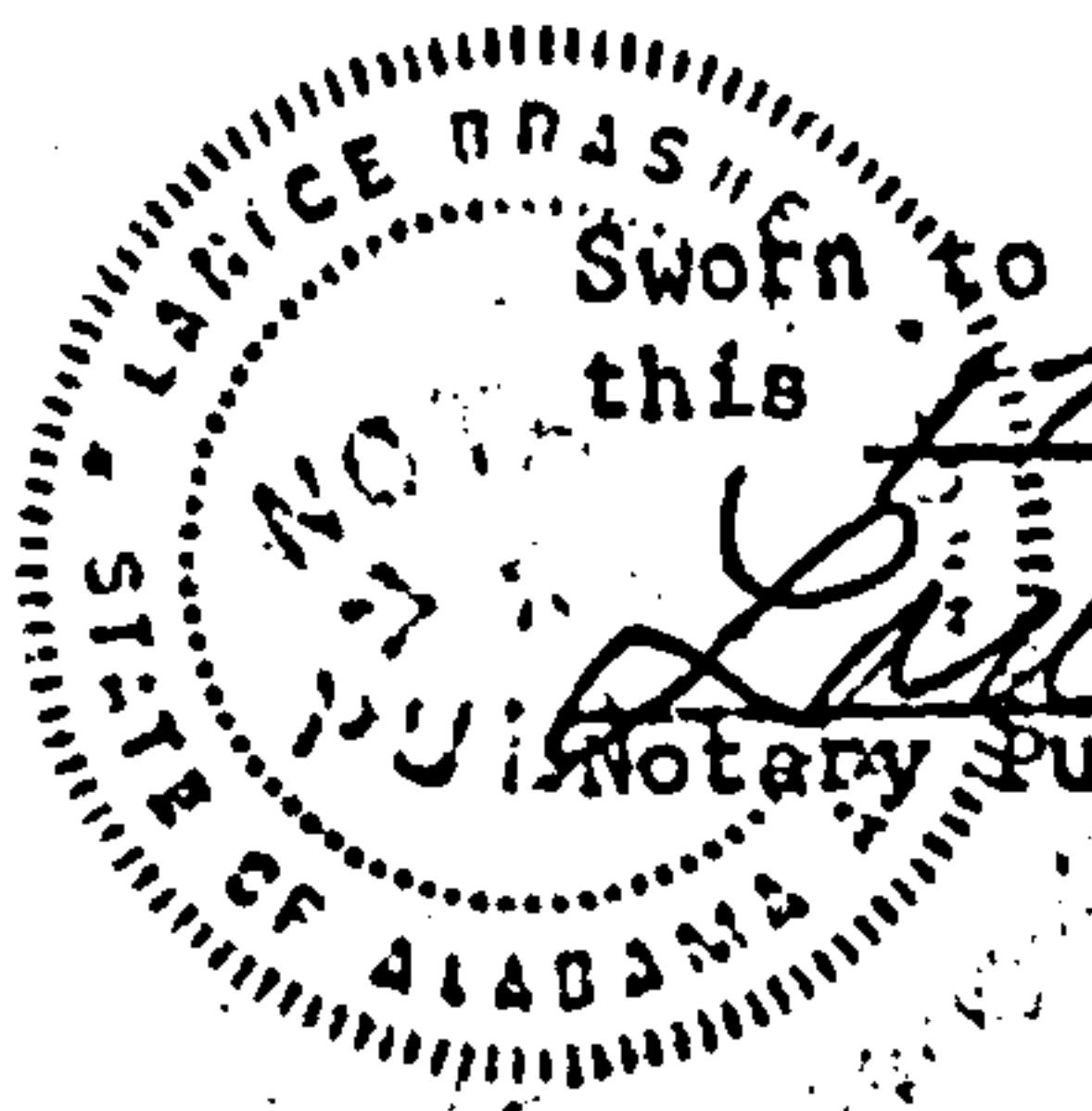
Further deposing, affiant says that at the present time Jerry E. Wood
