(herein referred to as grantors) do grant, bargain, sell and convey unto

(herein referred to as GRANTEEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Lot # 12 in Sector Two of Fall Acres Subdivision. Situated in and being a part of the  $SE\frac{1}{4}$  of the  $NE\frac{1}{4}$  of Section 3, Township 21 S, Range 3 West, Shelby County, Alabama. This is recorded in Map Book 5, page 16, in the Probate Office in Shelby County, Alabama.

Subject to Restrictions as Follows: "All lots are for residential purposes only, and dwellings shall have a minimum of 1,200 square feet in the main body of the house. No structures of a temporary nature, such as trailers, tents, shacks, basements, garages, or other outbuildings shall be used as a residence either temporarily or permanently", and this covenant shall attach to and run with the land.
