(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Subject to Restrictions as Follows: " All lots are for residential purposes only, and dwellings shall have a minimum of 1,200 square feet in the main body of the house.
