Southwest diagonal half of NE 1/4 of SE 1/4 of Section 16, Township 24, Range 15 East, Shelby County, Alabama.

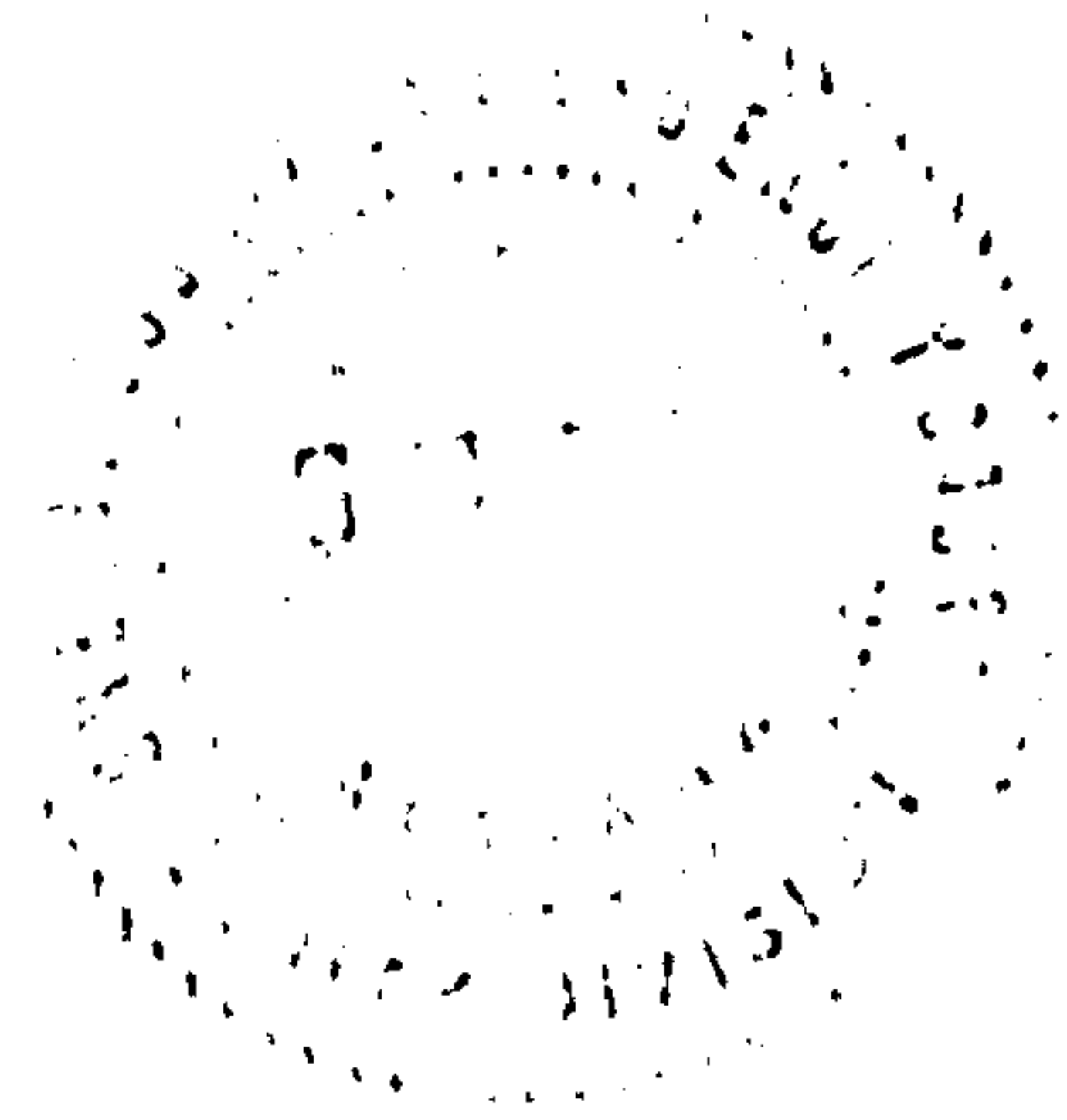
To have and to hold the aforegranted premises to the said _____


