the receipt whereof is hereby acknowledged, do grant, bargain, sell and convey unto said Georgia
Kraft Company the following described timber, to-wit:

All merchantable pine timber

Said timber now being, standing and growing upon the following described lands, situated in the County of Shelby
Shelby, and State of Alabama, to-wit:

Beginning at the intersection of the west line of the NE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 23, T18S, R2E and the county road then due north along said west line of NE $\frac{1}{4}$ of SE $\frac{1}{4}$ to branch, thence east along said branch to its intersection with Kelly Creek, thence south west along Kelly Creek to the east line of the SW $\frac{1}{4}$ of SW $\frac{1}{4}$, Section 24, T18S, Range 2E, thence along east line of said SW $\frac{1}{4}$ of SW $\frac{1}{4}$ to county road and thence north westerly along county road to point of beginning.

together with the right of ingress, egress, and regress for said Georgia Kraft Company

within six months from the date hereof. The Grantee shall have six months
from the date hereof to cut and remove said timber, and all timber remaining on said lands at
the expiration of said time shall then revert to and vest in the grantor s., their heirs or assigns.

TO HAVE AND TO HOLD the same to the said Georgia Kraft Company, its heirs, assigns,
and successors, forever. And we do, for ourselves and our heirs, executors, and
administrators, covenant with the said Georgia Kraft Company, its heirs, assigns, and
successors, that we lawfully seized in fee simple of the property herein conveyed; that it is free
from all incumbrance, and that we have a good right to sell and convey the said property; that we
will and our heirs, executors and administrators shall warrant and defend the
same to the said Georgia Kraft Company, its heirs, assigns, and
successors, forever, against the lawful claims of all persons whatsoever.

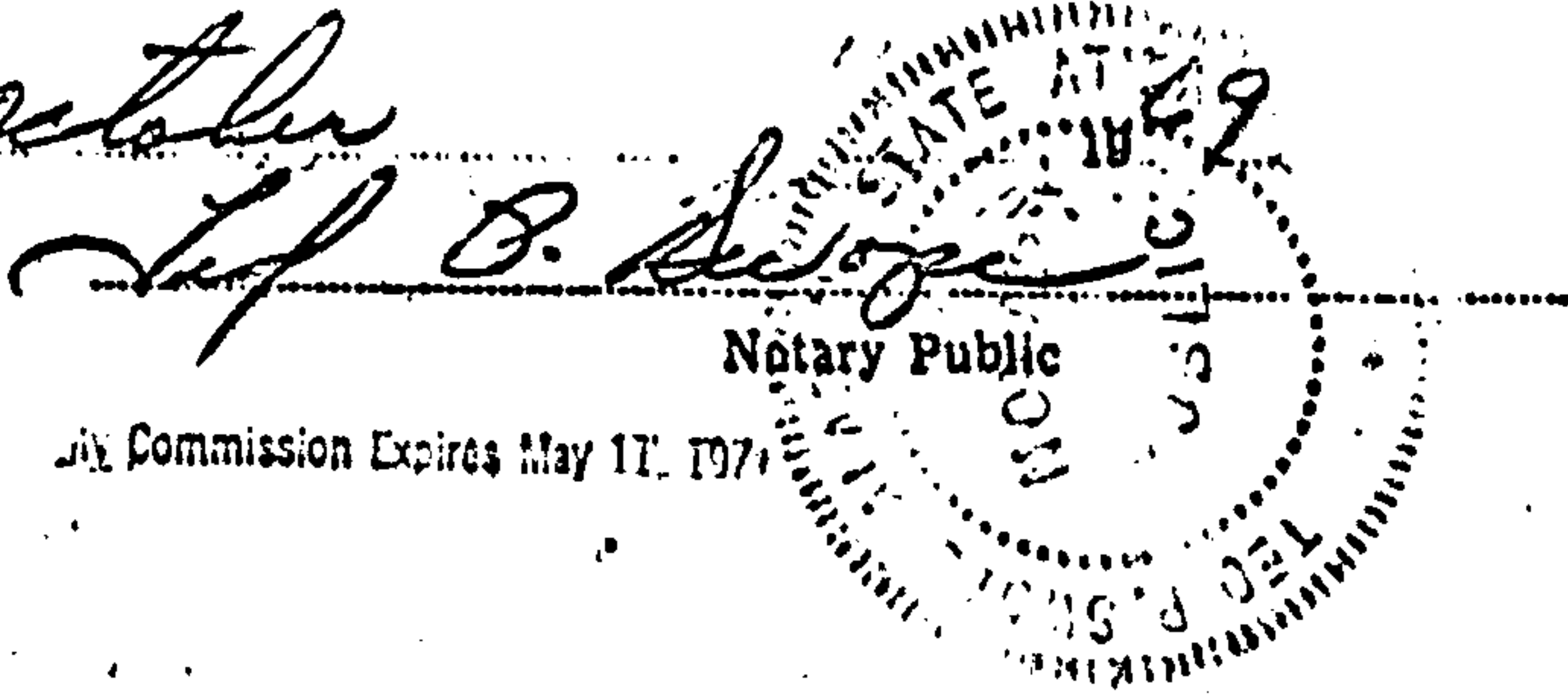
