hereby remises, releases, quit claims, grants, sells, and conveys to
Elbert W. Gibson

(hereinafter called Grantee), all our right, title, interest and claim in or to the fol-
lowing described real estate, situated in Shelby County, Alabama, to-wit:

A lot in the NE¼ of the SE¼ of Section 19, Township 21 South, Range 1 East, Shelby County, Alabama, described as follows: Commence at the NW corner of the NE¼ of the SE¼ of Section 19, Township 21 South, Range 1 East; thence run East, along the North line of said quarter-quarter section, a distance of 249.00 feet to the point of beginning; thence continue East along the North line of said quarter-quarter section a distance of 609.93 feet; thence turn an angle of 65 deg. 45 min. to the right and run a distance of 289.06 feet to the North right of way line of a County Highway; thence turn an angle of 85 deg. 48 min. to the right and run along said right of way line a distance of 44.30 feet to the P.C. of a right of way curve; thence continue along said curve(whose Delta Angle is 3 deg. 25 min. to the right, Radius is 5,686.44 feet, Tangent Distance is 170.42 feet, Length of Arc is 339.09 feet); thence turn an angle of 67 deg. 57 min. to right from Tangent of said curve, and run a distance of 280.27 feet; thence turn an angle of 44 deg. 55 min. to the left and run a distance of 184.00 feet; thence turn an angle of 89 deg. 12 min. to the right and run a distance of 240.00 feet to the point of beginning. Situated in the NE¼ of the SE¼ of Section 19, Township 21 South, Range 1 East, Shelby County, Alabama, according to survey of Frank W. Wheeler, Registered Land Surveyor, dated November 24, 1969.
