make afoot right-of-way acress our lands, said right-of-way herein conveyed being more

Commence at the northwest corner of Section 36, Township 19 South, Range 2 East, said point being at P. I. Station 61+35.9 of Project CP4-147 and run N 88 00'E along the north boundary line of said section a distance of 477.5 feet to a point of equation at P. O. T. Station 66+13.4 back = Station 64+08.4 ahead of said project: thence continue N 88 00 E along said north boundary line of said section a distance of 847.6 feet to the point of beginning at Station 72+56 of said project, said point being the northwest corner of the NE's of NWs. Section 36. Township 19 South, Range 2 East; thence continue N 88 00'E along the north boundary line of section 36 a distance of 312 feet to a point on the south 30 foot right of way line of said project; thence run westerly along said south 30 foot right of way line along a curve to the right (concave north erly) and having a radius of 984.93 feet a distance of 244 feet to a point 30 feet right of P. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
