Commence at the southeast corner of the NW% of SW%, Section 33, Township 17 South, Range 1 East and run N 73018'W a distance of 150.9 feet to a point on the centerline of Project CP4-27 (3) at P.O.T. Station 234+26.3; thence turn an angle of 11 00' to the right and run in a northwesterly direction a distance of 40.0 feet to the point of beginning on the northwest 40 foot fight of way line of said project; thence turn an angle of 90°00' to the left and run S 27°42'W along said northwest 40 foot right of way line a distance of 68.0 feet to a point on the south boundary line of the NW of SW4, Section 33, Township 17 South, Range 1 East; thence run in an easterly direction along said south boundary line of said quarter section and crossing centerline of said project at Station 234+73 a distance of 89.0 feet to a point on the southeast 40 foot right of way line; thence run in a northeasterly direction along said southeast 40 foot right of way line a distance of 225.0 feet to a point on the east boundary line of the NW4 of SW4.
