Before me, a Notary Public in and for said County and State, personally appeared Mike Lamar, who is known to me, and who being by me first duly sworn, deposes and says as follows:

My name is Mike Lamar and I am 57 years of age and reside at Route 1, Columbiana, Shelby County, Alabama.

My wife and I formerly owned the following described property, viz.:

Commence at the SW corner of the NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 15, Township 20 South, Range 1 West and run East along the quarter-quarter section line a distance of 420 feet to the point of beginning of land herein described; thence run North perpendicular to said quarter-quarter section line to intersection of the Southern boundary line of the Wilsonville-Pelham Public Road; thence run in a northwesterly direction along the south boundary of said road 150 feet; thence run South and parallel with East line of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ and the NE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 15, To a point due west of the SW corner of a two square acre tract in the NE corner of the west Half of SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 15; thence run East to the SW corner of the two acre tract; thence North along the Western boundary of said two acre tract to the North line of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 15; thence run East along North line of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 15, to the point of beginning.

We bought said property from Mr. Sam R. Vick and his wife in August, 1956, and within a year thereafter we built a house on said property, which we occupied as our homestead continuously since early in 1957 until about a month or so ago when we conveyed said property to Mr. William L. Berryhill and wife, Jewell C. Berryhill.

I have been familiar with said property for at least twenty years prior to the time when my wife and I bought the same in 1956, and I know that it was owned by Mr. Sam R. Vick and the other heirs of his father, Jessie C. Vick, during said twenty year period. At the time when I bought said property,

about half of the land was cleared and about half was in woods.

I have never heard of J. L. Peters, J. C. Harper, or N. H. Edmondson claiming or possessing said property, or any part thereof. In fact, I know that none of said persons have been in possession of said property, or any part thereof, since I have been familiar with the same.

I know of my own personal knowledge that my wife and I, and our predecessors in title, namely, Sam R. Vick and wife, and the other heirs of Jessie C. Vick, have been in the actual, open, continuous, notorious, undisturbed, peaceable, exclusive, hostile, adverse possession of said property for more than thirty years prior to the time when my wife and I conveyed said property to Mr. and Mrs. William L. Berryhill about a month or so ago.
