That in consideration of Five Hundred and No/100 and other valuable consideration DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,

John L. Kidd and wife, Inez R. Kidd,

(herein referred to as grantors) do grant, bargain, sell and convey unto

Lee O. Miller and wife, Mary W. Miller,

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated

in SHELBY COUNTY County, Alabama to-wit:

Lots No. 3 and 4, Survey No. 1. Description of Lot No. 3 shown below, ~~and description of Lot No. 4 is attached.~~

Commence at the NW corner of Sec. 34, Township 19, South, Range 2, East, Shelby Co. Alabama, thence proceed East along the No. boundary of said Sec. 34 for a distance of 308.2 feet to the point of beginning of the land herein described. From this beginning point, turn an angle of 109 degrees 56' to the right and proceed Southwesterly for a distance of 396.4 feet to a point on the north side of a paved street, this point being 30 feet from the center line of said road or street, thence proceed Southeasterly along the North side of said street for a distance of 104 feet to a point, thence proceed Northeasterly for a distance of 483.25 feet to a point on the north boundary of said Section, thence turn an angle of 115 degrees and 01' to the left and proceed West along the North boundary of said Section for a distance of 150 feet to the point of beginning.

The above described land is located in the NW 1/4 of the N/W 1/4 of Sec. 34, Township 19 South, Range 2 East, Shelby County, Alabama and contains 1.21 acres.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.

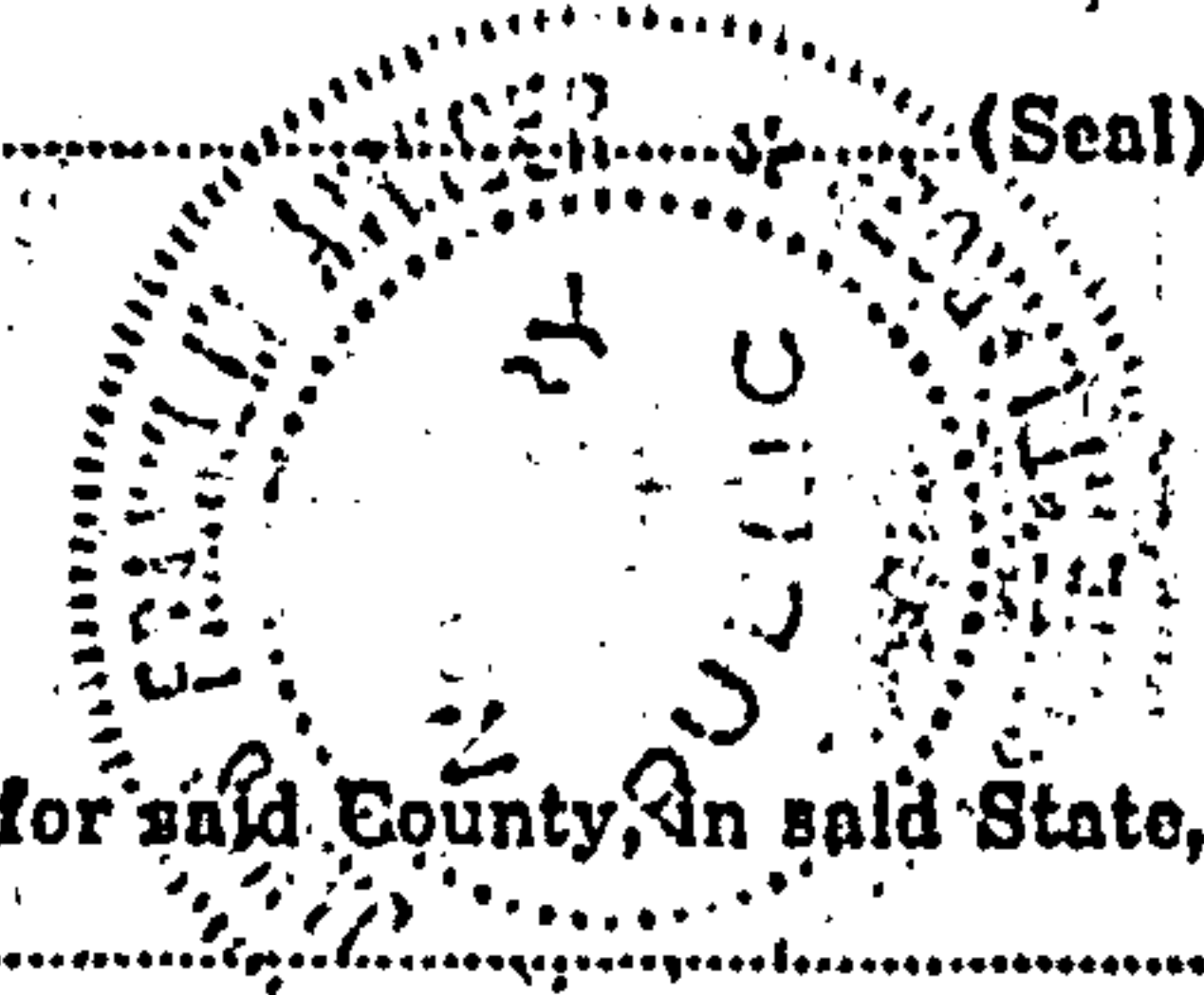
