Hange I Lest, and run thence north along the cast line of said forty acres 615 feet; thence run west and parallel with the south line of said forty acres 495 feet; thence run south and parallel with the cast line of said forty acres 615 feet to the south line thereof; thence run east along the south line of said forty acres 495 feet to the point of beginning, being 7 acres, more or less.
