MORTGAGE RELEASE

KNOW ALL MEN BY THESE PRESENTS, That The City National Bank of Tuscaloosa, for and in consideration of One and No/100 (\$1.00) Dollar, and other good and valuable considerations, the receipt whereof is hereby acknowledged, does hereby remise, release, and discharge the property hereinafter particularly described from the lien of that certain mortgage executed by R. F. Holifield and wife, Belle A. Holifield, to The City National Bank of Tuscaloosa, dated the 1 day of June, 1967, recorded in the Probate Office of Shelby County, Alabama, in Mortgage Book 306, at Page 883, said property being located in Shelby County, Alabama, being more particularly described as follows:

Commence at the SE corner of the NE1/4 of SE1/4 of Section 4, Township 22 South, Range 2 West and run thence North along the East line of said quarter-quarter section a distance of 160.34 feet to the point of beginning; thence turn an angle of 69 deg. 42 min. to the left and run a distance of 119.34 feet; thence turn an angle of 28 deg. 40 min. to the left and run a distance of 320.10 feet; thence turn an angle of 110 deg. 08 min. to the right and run a distance of 121.90 feet; thence turn an angle of 29 deg. 18 min. to the right and run a distance of 293.75 feet; thence turn an angle of 3 deg. 54 min. to the left and run a distance of 349.00 feet to a point on the East line of said quarter-quarter section; thence run South, along the East line of said quarter-quarter section, a distance of 613.75 feet to the point of beginning.

It is hereby expressly understood that this release shall not affect or impair the security of said mortgage upon any portion of any property except the property hereinabove particularly described.
