

MORTGAGE RELEASE

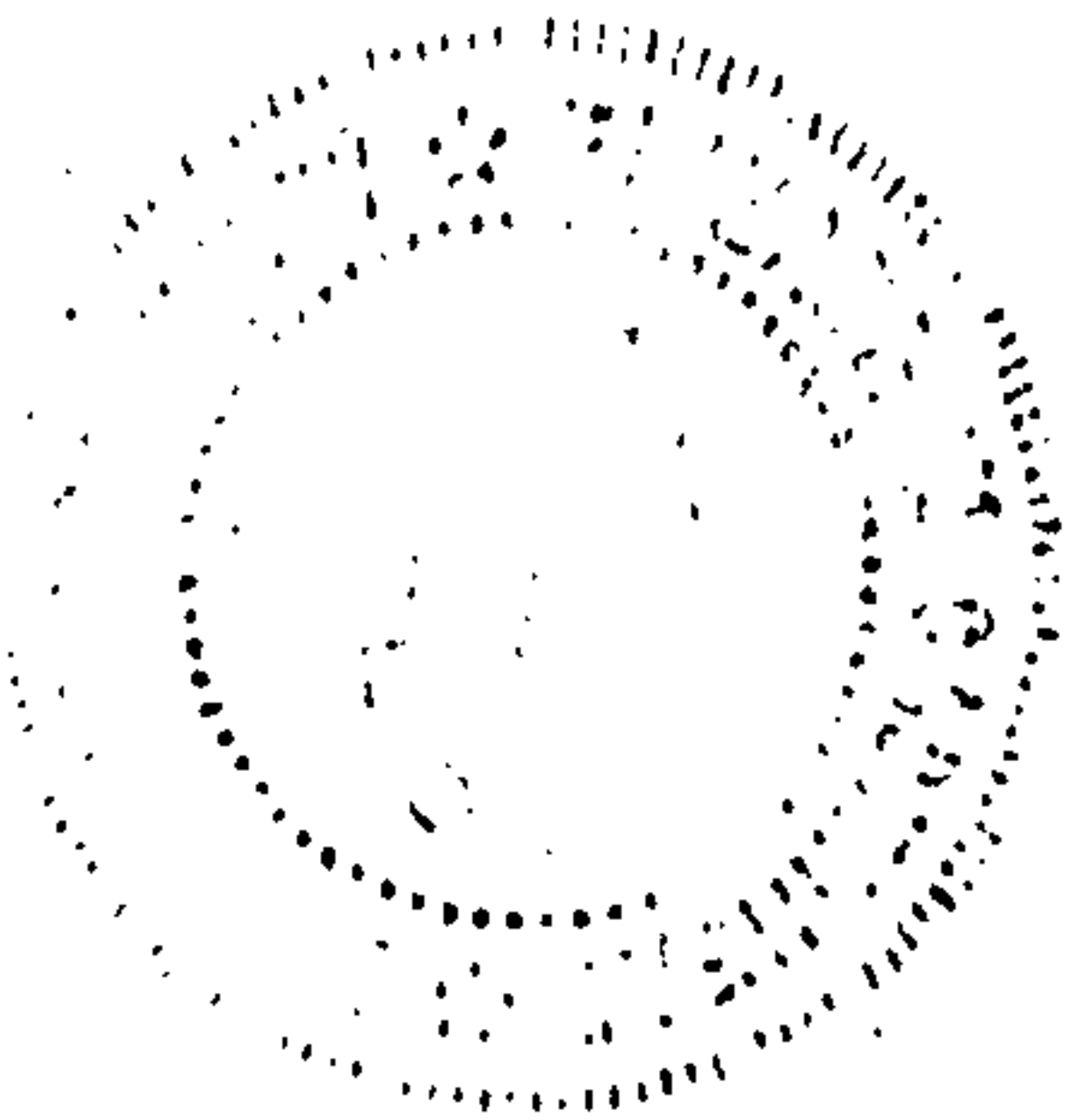
