Before me, the undersigned authority in and for said county in said state, personally appeared Joe DeBardeleben, who, after being by me first duly sworn to speak the truth, deposes and says:

My name is Joe DeBardeleben, I am 31 years of age and have lived in Calera, Shelby County, Alabama, some 40 to 50 years and have all along been familiar with the hereinafter described land and the persons in possession of the same. Said land being described as follows:

All of Block R according to Resurvey of Russell R. Hetz property as recorded in Map Book 3 on page 119 in Probate Office of Shelby County, Alabama; being situated in Calera, Shelby County, Alabama.

I do not know the details as to when Southern Lime Corporation bought and sold said land, but I do know when Russell R. Hetz purchased the same from said Corporation on December 31, 1945. Mr. Hetz re-surveyed said property and was in the actual possession of it until March 19, 1949, when he and his wife sold said Block to H. G. Matthews on the 14th day of March, 1949 as shown in Deed Book 140, page 160 in the Probate Office of Shelby County, Alabama. Mr. H. G. Matthews went into immediate possession of said real property and he lived in Calera not far from the property and I recall distinctly that almost every Sunday morning, if the weather was not too bad, he would go out on the property and would be around on it and I would pass him when I went back and forth to Church and I know he was in actual possession of the same and paid taxes until his death some 10 or 12 years ago, (I am not sure the exact number of years) after which time his wife, Mrs. H. G. Matthews, went into possession of the same and paid taxes on the same and owned it until this very day. Said block is bordered on the East by 13th Street and on the West by Lucille Wood property. Affiant further says that he knows that throughout the years since Mr. Hetz owned said property in 1949 until this very day, that he has never heard of anyone contesting the possession of Mr. H. G. Matthews or his heirs; nor, has he heard of anyone disputing their title. Affiant says that said persons have been in actual possession of said property throughout all of the years as mentioned above.
