do grant, bargain, sell and convey unto the said Wayne M. Walker & wife, Stella N. Walker,

as joint tenants, with right of survivorship, the following described real estate, situated in

County, Alabama, to-wit:

The Southwest Quarter of the Southwest Quarter, Section 10, Township 24 North, Range 12 East, Shelby County, Alabama and containing 40 acres, more or less, and subject, however, to a reservation of mineral and mining rights reserved prior to this conveyance.

The Northwest Quarter of the Northwest Quarter, Section 15, Township 24 North, Range 12 East and the Northeast Quarter of the Northeast Quarter, Section 16, Township 24 North, Range 12 East, in Chilton County, Alabama and containing 80 acres, more or less, and subject, however, to a reservation of mineral and mining rights reserved prior to this conveyance.

The land herein described lying and being partly in Shelby County, Alabama and partly in Chilton County, Alabama, and containing in the aggregate 120 acres, more or less.

TO HAVE AND TO HOLD Unto the said Wayne M. Walker & wife, Stella N. Walker,

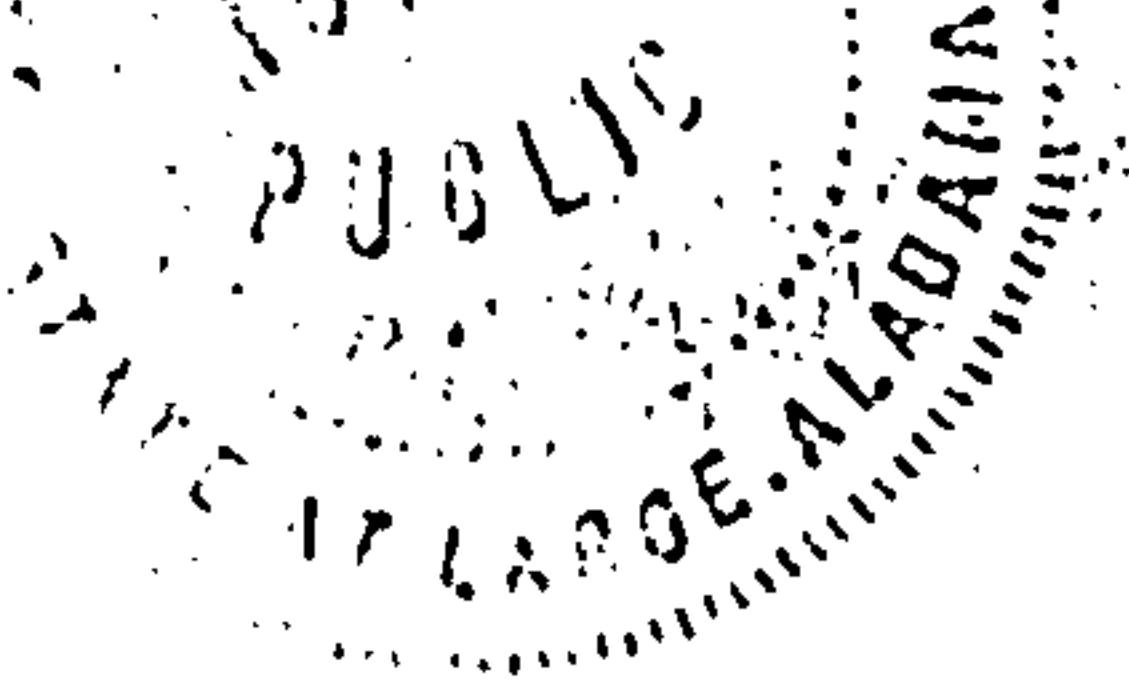
