(hereinafter called Grantee), all our right, title, interest and claim in or to the following described real estate, situated in Shelby County, Alabama, to-wit:

3 1/2 of 3 1/2 of Section 17, Township 24, Range 12 East except the following described land: one acre square off the SW corner of SW 1/4 of SE 1/4 in said Section 17.
