My mother, the said Ophelia Roy, died July 11, 1969 and left as her sole heirs at law Jasper W. Roy, to me who was a single man on July 16, 1969, when he and others executed a deed/recorded in Deed Book 253, page 723; Johnnie Margaret Roy Lovelady, whose husband was Lester E. Lovelady; and Bonnie F. Roy Mathis, whose husband was James D. Mathis; and myself, Floyd J. Roy, and on the 16th day of July, 1969, all of the said persons were over the age of 21 and of sound mind.
