That for and in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration to the said Grantor, in hand paid by the Grantee, the receipt whereof is hereby acknowledged, the said Grantor does hereby grant, bargain, sell and convey unto the Grantee, the following described real estate, situated in Shelby County, Alabama, to-wit:

Northeast Quarter (NEt) of Northeast Quarter (NEt), West Half (W2) of Northeast Quarter (NEt), Northwest diagonal half of Southeast Quarter (SE1) of Northeast Quarter (NE1) West Half (W2) of Southeast Quarter (SE1), East Half (E2) of Southwest Quarter (SW $\frac{1}{4}$), East Half ($E_{2}^{\frac{1}{2}}$) of Northwest Quarter (NW1) of Southwest Quarter (SW1) and Northwest Quarter (NWI), except a tract described as follows: Commencing at the northwest corner of Northwest Quarter (NWL) of Northwest Quarter (NWL), run south along the west line of said quarter-quarter section a distance of 504.5 feet to the southeast right-ofway line of the Helena-Acton paved highway for a point of beginning; thence turn an angle to the left of 153° and run along the southeast line of said highway a distance of 150 feet; thence turn an angle to the right of 101°30' and run in a southeasterly direction 400 feet to a point; thence turn an angle to the right of 113° and run in a southwesterly direction a distance of 427 feet to the west line of said quarter-quarter section; thence turn an angle to the right of 118° and run north along said west line a distance of 325.3 feet to the point of beginning; all in Section 1, and all that part of Northwest Quarter (NW1) of Northeast Quarter (NEt) of Section 12 lying northwest of the right-of-way of the new Birmingham-Montgomery Highway, all in Township 20 South, Range 3 West, Shelby County, Alabama.

1. Such easements as may exist over, upon or across said land for railroads, public roads, electric transmission lines, telephone lines, telegraph lines, pipe lines and other existing easements, including easement to Alabama Power Company for transmission line dated September 22nd, 1970.

2. Existing leases and Zoning Ordinances pertaining to said land.

And said Grantor, for itself, its successors and assigns, does hereby covenant with the said Grantee, its successors and assigns, that it is lawfully seized in fee simple of the premises hereby conveyed, that it has a good right to sell and convey the same as aforesaid and that said premises are free from all encumbrances except as above stated; and that it will, and its successors and assigns shall, warrant and defend the same to the said Grantee, its successors and assigns, forever; against the lawful claims of all persons whomsoever, except as above stated.
