RIGHT-OF-WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

and wife _ County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be see below ___feet in width on ______ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to see below foot right-of-way acress our lands, said right-of-way herein conveyed being more particulary described as follows, to-wit: And as shown on the right-of-way map of Project No. CP1-145as recorded in the office of the Judge of Probate of Shelby County.

Commence at the northwest corner of SE4 of SE4, Section 14, T 22, R 1 W and run south along the west boundary line of said quarter quarter section a distance of 22.0 feet to a point on the northeast 40' right of way line of Project CP1-145; thence run in a southeasterly direction along said northeast 40 foot right of way line along a curve to the right (concave southwesterly and having a radius of 858.51') a distance of 146.0 feet to a point 40' left of P.T. Station 285+37.6; thence run S 52°24'E along said northeast 40' right of way line a distance of 679.8' to a point 40' left of P.C. All agreements, covering the moving, relocating and/or changing of the building and/or structures located wholly or partially on the above described right-of-way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
