Section of Shelby Memory Gardens, Inc., a cemetery situated in Shelby County, in the State of Alabama, in accordance with the plat thereof duly recorded in the office of the party of the first part, and as therein shown, said lot to be used for no other purpose and in all respects and at all times subject to the By-Laws, rules and regulations now existing, or which shall hereafter be adopted by the party of the first part or by any duly authorized association whose membership shall be composed of those having rights of sepulture under similar indentures.

The above described property shall have the benefit of the perpetual maintenance trust fund now in hand and to be created by Shelby Memory Gardens, Inc., and the owner and holder of this indenture or if it be jointly owned then one of such joint owners shall be entitled to membership in any association whose membership shall be composed of those having rights of sepulture under similar indentures.

TO HAVE AND TO HOLD unto the part Y of the second part his heirs and assigns forever. This indenture is subject to the limitations above mentioned and for the uses and purposes hereinbefore expressed; and the rights herein granted may be sold, transferred or assigned by the party of the second part, but such a sale or transfer shall not be binding in any event upon Shelby Memory Gardens, Inc., until this original indenture shall have been presented at its offices in Shelby County, Alabama, and the transfer thereof duly recorded upon this indenture and upon the records of the Shelby Memory Gardens, Inc., and a transfer fee paid to first party. By the receipt of this certificate party of the second part agrees to pay to party of the first part a transfer fee if party of second part sells or transfers all or any part of the above described lot.
