WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR—LAWYERS TITLE INSURANCE CORPORATION, Birmingham, Alabama

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Twenty-eight Hundred and no/100----- DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,
James J. Martin and wife, Marjorie Martin

(herein referred to as grantors) do grant, bargain, sell and convey unto

Herbert B. Stone and Inez Davis Stone

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Commence at the intersection of the easterly right-of-way line of Mill Street and the northerly right-of-way line of 4th Avenue West, said right-of-way lines as shown on the Map of the Dedication of the Streets and Easements, town of Siluria, Alabama; thence northeasterly along said right-of-way line of 4th Avenue West for 33.00 feet to the point of beginning; thence 91 deg. 01 min. 36 sec. left and run northwesterly for 183.65 feet; thence 37 deg. 34 min. 06 sec. right and run northeasterly for 124.47 feet; thence 90 deg. 12 min. 31 sec. right and run southeasterly for 196.45 feet to a point on the northerly right-of-way line of 4th Avenue West; thence 93 deg. 14 min. 59 sec. right and run southwesterly along said right-of-way line of 4th Avenue West for 132.00 feet to the point of beginning.
