**Exhibit A**

**DESCRIPTION**

A parcel of land situated in the Southwest Quarter of Section 16, Township 19 South, Range 2 West, Shelby County, Alabama, being more particularly described as follows:

Begin at the Southeast corner of Lot 1, Block 7, according to the survey of Indian Valley First Sector as recorded in Map Book 5, Page 43, in the Office of the Judge of Probate, Shelby County, Alabama; thence run in a Northwesterly direction along the North-easterly lines of said Lot 1, Block 7, and Lot 2, Block 7, in said survey of Indian Valley First Sector a distance of 362.24 feet; thence turn an angle to the left of 1 degree 25 minutes 56 seconds, continuing in a Northwesterly direction a distance of 50.02 feet; thence turn an angle to the right of 1 degree 25 minutes 56 seconds and run in a Northwesterly direction a distance of 349.61 feet; thence run in a Northeasterly and Easterly direction along the arc of a curve having a central angle of 26 degrees 41 minutes 08 seconds and a radius of 733.01 feet a distance of 341.40 feet along the arc of said curve (the angle from previously described course to the chord of said curve being 99 degrees 57 minutes 11 seconds) to the end of said curve; thence continue in an Easterly direction along the tangent extended to previously described curve a distance of 257.15 feet to it's intersection with the East line of the Northeast Quarter of the Southwest Quarter of said Section 16; thence run in a Southerly direction along the East line of said quarter-quarter a distance of 534.23 feet to the Southeast corner of said quarter-quarter; thence turn an angle to the right of 45 degrees 27 minutes 23 seconds and run in a Southwesterly direction a distance of 304.71 feet to it's intersection with the Northwesterly right-of-way line of Valley Dale Road; thence run in a Southwesterly direction along the Northerly right-of-way line of said Valley Dale Road along the arc of a curve having a central angle of 2 degrees 58 minutes 57 seconds and a radius of 1,469.21 feet, a distance of 76.48 feet to the point of beginning.
