the receipt whereof is acknowledged I the said Robert Howard Bailey, a single man

do grant, bargain, sell and convey unto the said William L. Caldwell and Reba Bailey Caldwell

the following described real estate, situated in Shelby
County, Alabama, to-wit:

Begin at the Southeast Corner of the Northeast Quarter (NE $\frac{1}{4}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section 10, T - 19 - S, R-2W Huntsville Meridian, Shelby County, Alabama, thence west along the south line of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$, 681.4 feet to a point. This point will hereinafter be known as the point of beginning. Beginning at the point of beginning, thence turn an angle of 73° - 35' to the right and continue in a northwesterly direction 317.5 feet to the centerline of the road, in a southwesterly direction 200.0 feet to a point at its intersection with the east right-of-way line of Caldwell Mill Road, thence continue in a southeasterly direction along the east right-of-way of Caldwell Mill Road, 212.0 feet to its intersection with the south line of the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 10, T - 19 - S, R-2W, thence continue east 222.0 feet along the Quarter line to the point of beginning.
