Before me, the undersigned authority in and for the State of Alabama at Large, personally appeared Alma S. Mathers, who, after being by me first duly sworn to speak the truth, deposes and says:

My name is Alma S. Mathers. I am 21+ years of age and have owned the hereinafter described property for several years. Said property being described as follows:

The $\frac{1}{2}$ of SW $\frac{1}{4}$ and all that part of the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ which lies south of Columbiana-Tuscaloosa public road and west of a spring branch which runs through said forty acres in Section 2, Township 22 South, Range 3 West;

Also the $\frac{1}{2}$ of SE $\frac{1}{4}$ and all that part of the SE $\frac{1}{4}$ of NE $\frac{1}{4}$ which lies south of the Columbiana-Tuscaloosa Public road in Section 3, Township 22 South, Range 3 West;

Situated in Shelby County, Alabama.

There has been called to my attention a deed from Clarence E. Holmes to Alma S. Holmes dated July 20, 1945. I was formerly the wife of Clarence E. Holmes, but we divorced after said deed was executed and in 1950, I married John F. Mathers.

There has been called to my attention a Transmission Line Permit from Mary Ida Wooley to Alabama Power Company dated August 14, 1943, recorded in Deed Book 134 page 535 in Probate Office. I do not know Mary Ida Wooley, but know she has never owned or made any claim to the above described land since I have known the same, which has been for more than 25 years.

There has also been called to my attention a Transmission Line Permit to Alabama Power Company dated October 27, 1955 given by J. M. Self and Eula M. Self. It is my understanding the Selfs owned some land north of the old Columbiana-Tuscaloosa public road, but I am certain they have never owned or claimed any interest in the above land since I have known the same.

There has also been called to my attention a Transmission Line Permit to Alabama Power Company dated May 23, 1956, from L. W. Wooten and Lummie P. Wooten. I know said parties signing said Permit have never during the 25 years or more that I have known the land, made any claim or asserted any interest in the land.
