
RELEASE FROM LIEN OF MORTGAGE

Hughes & husband, David Durham Hughes who claims to be the present owner, all of the right, title and interest of the undersigned in and to the following described property in ... Shelby..... County, Alabama, to-wit:

Commence at the Southeast corner of the Northeast Quarter of the Southwest Quarter of Section 13 and run North along the East line of said Quarter-Quarter section a distance of 330 feet to the point of beginning of the property herein described: thence an angle to the left of 87°30' and run westwardly and parallel with the south line of said quarter-quarter section a distance of 414.71 feet to the easterly right of way line of Oak Mountain Park Road (having a width of 80 feet); thence an angle to the right of 110°10' and run northwardly along the east line of said right of way a distance of 175.63 feet; thence an angle to the right of 69°50' and run eastwardly and parallel with said south line of said Quarter-Quarter section a distance of 346.93 feet; thence an angle to the right of 87°30' and run southwardly and along the east line of said Quarter-Quarter section a distance of 165 feet to the point of beginning. Said tract containing 1.44 acres.
