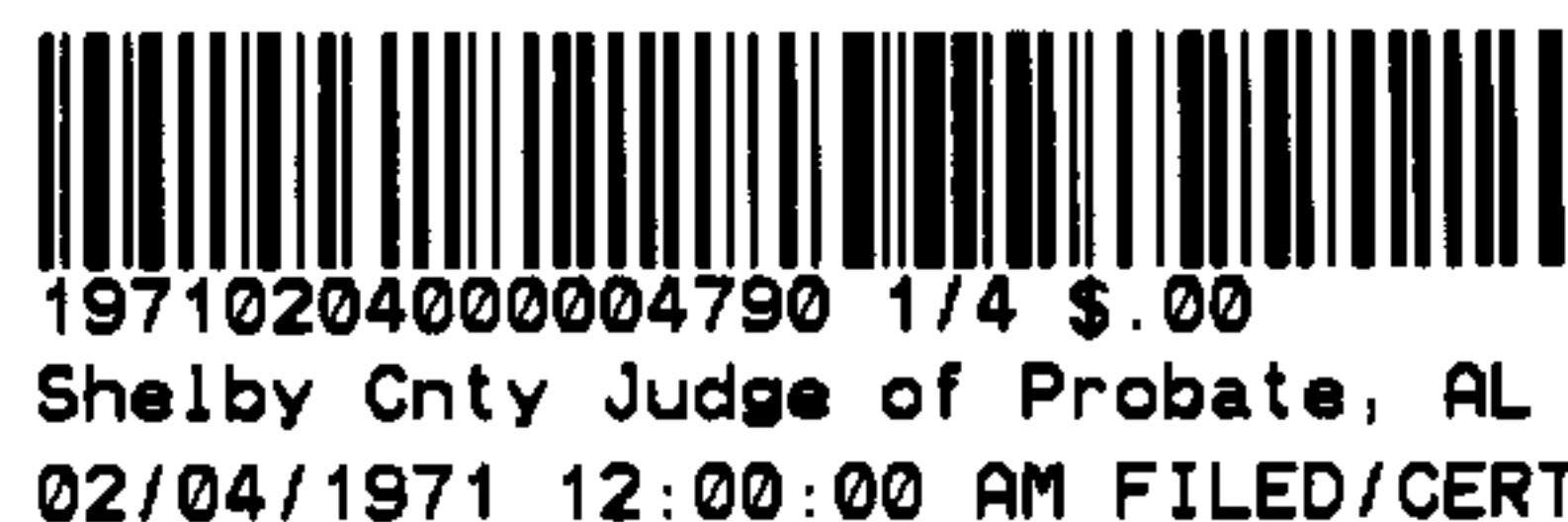

KNOW ALL MEN BY THESE PRESENTS, that the undersigned,

Diamond Automation Inc., Lawler Division

for and in consideration of the sum of One and No/100 Dollars (\$1.00), to it in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, does hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, install, operate and maintain, and the right to permit other corporations and persons to construct, install, operate and maintain, along routes to be selected by the grantee, (generally shown crosshatched on the attached drawing) its successors or assigns, all poles, wires, conduits, cables, trans closures and other appliances and facilities useful or necessary in connection therewith, for the overhead and underground transmission and distribution of electric power and for the overhead and underground communication service, upon, over, under and across the following described land, situated in Shelby County, Alabama:

Begin at the southeast corner of southwest quarter of northeast quarter, Section 6, Township 24 north, Range 13 east, thence west along south line of forty 576.0 feet; thence 90° right 75.0 feet; thence 90° left 120.0 feet; thence 90° left 75.0 feet; thence 90° right along south line of forty 415.51 feet to southeast border of a paved County Road; thence 122° 43' right along said border 819.54 feet; to the intersection with highway 25; thence 53° 23' right along the southside of said highway 678.60 feet to the East line of forty; thence 94° 31' right along East line 733.91 feet to point of beginning.
