

# The United States of America,

To all to whom these presents shall come, Greeting:

WHEREAS, it appears from the records of the Bureau of Land Management, and from other available evidence, that Henry W. Collier, assignee of Pis-at-am-te-mah, has located at the Land Office at Huntsville, Alabama, on January 20, 1853, Choctaw Certificate No. 880-B for 160 acres of land, issued by the Secretary of War in pursuance of the provisions of the Act of Congress of August 23, 1842, entitled "An Act to provide for the satisfaction of claims arising under the fourteenth and nineteenth Articles of the Treaty of Dancing Rabbit Creek, concluded in September, one thousand eight hundred and thirty;" of the Act of Congress of March 3, 1845, entitled "An Act making appropriations for the current and contingent expenses of the Indian Department, and for fulfilling treaty stipulations with the various Indian tribes, for the fiscal year commencing on the 1st day of July 1845, and ending on the 30th day of June, 1846", and the Joint Resolution of Congress of August 3, 1846, entitled "Joint Resolution to authorize the Secretary of War to adjudicate the claims of the Su-quak-natch-ah and other clans of Choctaw Indians, whose cases were left undetermined by the Commissioners for want of the township maps," in full satisfaction for the lands hereinafter described:

Huntsville Meridian, Alabama.  
T. 21 S., R. 1 W.,  
Sec. 23, NW $\frac{1}{4}$ .

The area described contains 159.42 acres, according to the Official Plat of the Survey of the said Land, on file in the Bureau of Land Management; and,

WHEREAS, There is now deposited in the Bureau of Land Management, an Order of its Director dated November 14, 1957, directing that a patent be issued for said Land under the location of said Certificate:

NOW KNOW YE, That the UNITED STATES OF AMERICA, in consideration of the premises, and in conformity with the several Acts of Congress in such case made and provided, HAS GIVEN AND GRANTED, and by these presents DOES GIVE AND GRANT unto the said Henry W. Collier, and to his heirs, the tract of Land above described; TO HAVE AND TO HOLD the same, together with all the rights, privileges, immunities, and appurtenances, of whatsoever nature, thereunto belonging, unto the said Henry W. Collier, and to his heirs and assigns forever.
