Byars Assistant Secretary of Liberty National Life Insurance Company, a corporation organized and existing under and by virtue of the laws of the State of Alabama, do hereby certify that at a meeting of the board of directors of Liberty National Life Insurance Company duly called and held at its office in Birmingham, Alabama on September 22, 1970, at which a quorum was present and voted, the following resolutions were unanimously adopted by the said board of directors, and are still in force and unrevoked on the date hereof:

"RESOLVED, that either E. A. Camp, Jr., Harold H. Hays, H. R. Lenderman, T. K. Roberts, O. E. Rollings, Jr., Elmore Scott or A. M. "BE IT FURTHER RESOLVED, that the authority heretofore granted to certain persons by resolution adopted March 17, 1964 is hereby terminated and superseded by the foregoing resolution."
