Thence run northward and parallel to the east line of Sec. 10 for a distance of 418.0 ft. Turn 90 degrees westward and run 350.0 ft. Turn 90 degrees Southward and run 558.0 ft. to the north bank of Spring Creek. Thence run E-NEly along the north bank of Spring Creek 377.0 ft. to the point of beginning.

A parcel of land containing three and zero-tenths (3.0) acres, more or less, and located in Sec. 10, T-19-S, R-2-E, and more particularly described as follows: Commence at the intersection of the east line of Sec. 10 and the north bank of Spring Creek and run W-SW ly along the north bank of Spring Creek 160.0 ft. Thence continue to run W-SW ly along the north bank of Spring Creek 377.0 ft. to a point of beginning. Thence run northward and parallel to the east line of Sec. 10 for a distance of 558.0 ft. Turn 90 degrees westward and run 220.0 ft. Turn 90 degrees southward and run 634.0 ft. to the north bank of Spring Creek. Thence run E-NE ly along the north bank of Spring Creek 233.0 ft. to the point of beginning.

Except as hereinabove provided, said mortgage shall remain in full force and effect.
