All of the northwest quarter of the northeast quarter of Section 3, Township 19 south, Range 2 west.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said facilities and the right to excavate for installation,

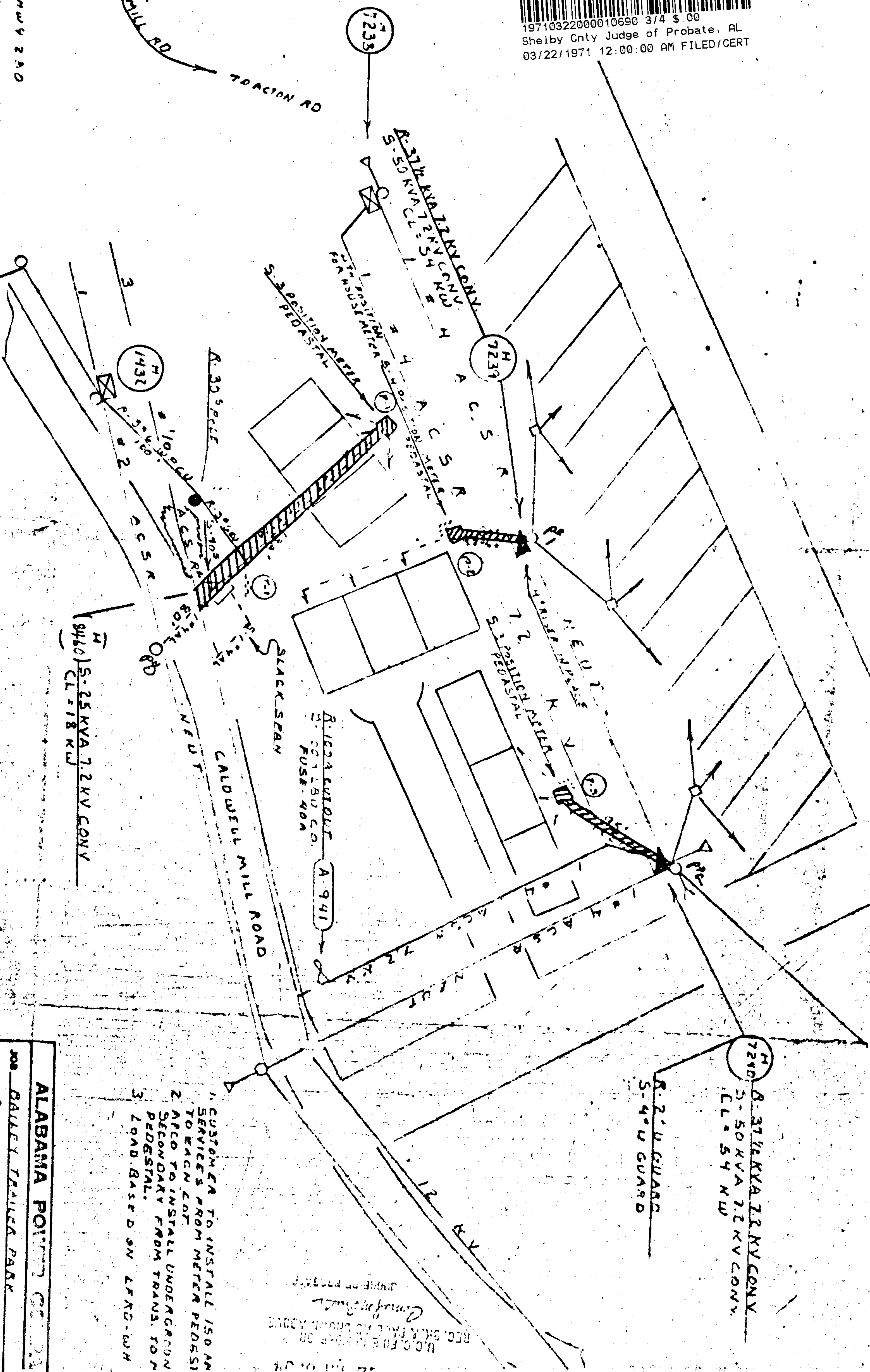
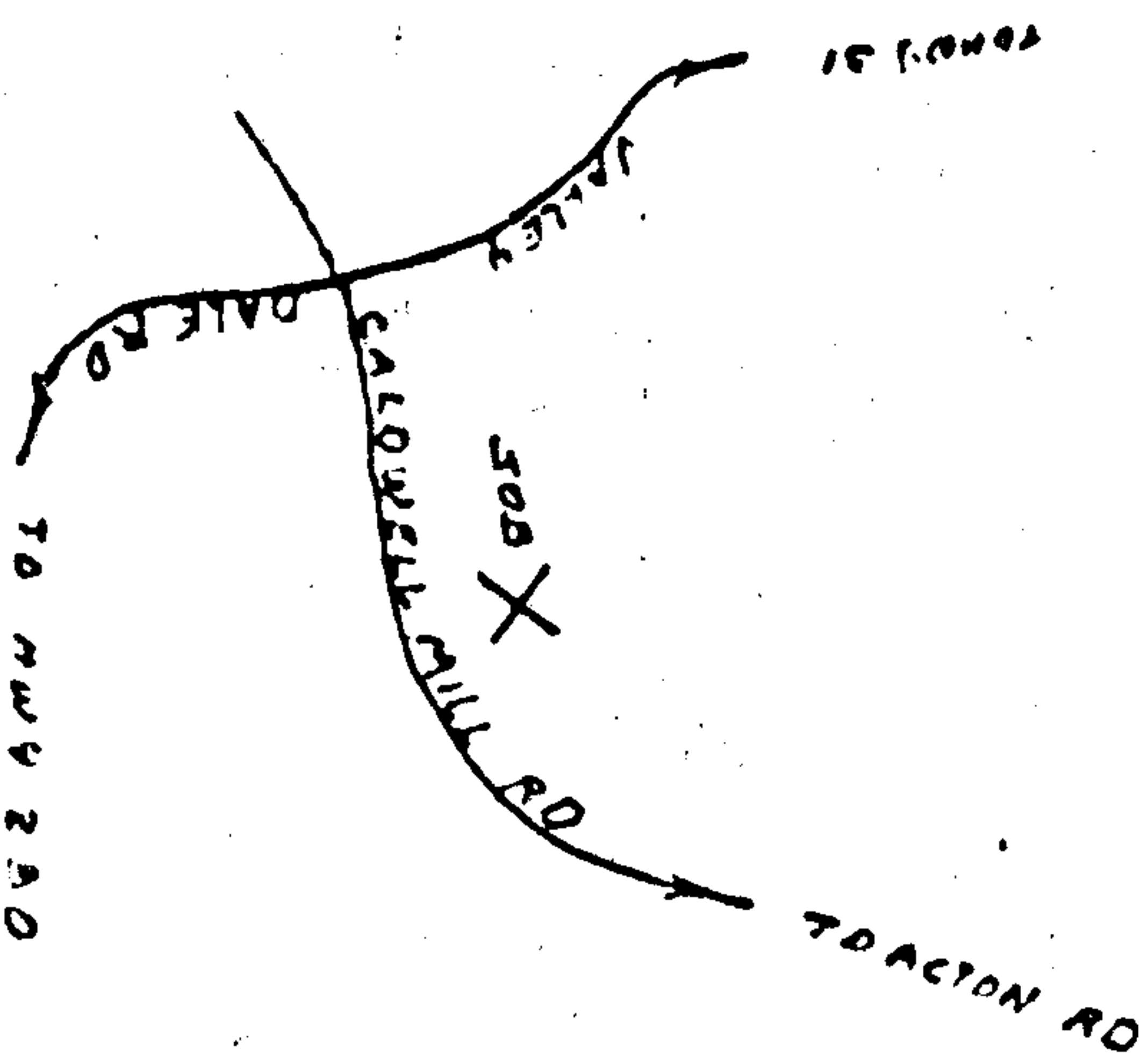
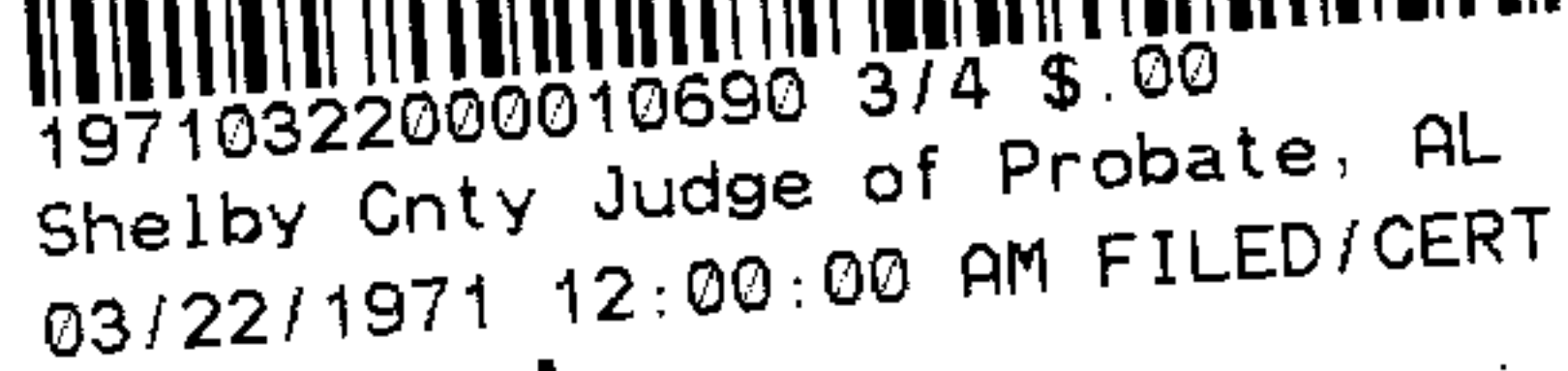
