All that portion of the east half of the southeast quarter of Section 3, Township 22 south, Range 3 west that lies south of Highway 22; all that portion of the southeast quarter of the northeast quarter of said section that lies south of Highway 22; a strip of land in Section 2, Township 22 south, Range 3 west, bordering on the westside of said section and having a uniform width of 220.0 feet and extending northward from the south side of said section to Highway 22, according to survey made on March 29, 1969.
