SUPPLEMENTAL  
LEASE AGREEMENT

WHEREAS, on September 23, 1969, a lease was entered into between PURE OIL  
as Lessee,  
DIVISION, UNION OIL COMPANY OF CALIFORNIA/and T. J. Wakefield as Lessor, which lease  
was recorded in Deed Book 260, page 069 in the Probate Office of Shelby County, Alabama;

WHEREAS, Lessee has changed its Division name from PURE OIL DIVISION, UNION  
OIL COMPANY OF CALIFORNIA to UNION 76 DIVISION, UNION OIL COMPANY OF CALIFORNIA;

WHEREAS, it was the intention of said lease to describe only the land  
described in this supplemental agreement but through some inadvertance there was  
land  
described in said lease more/than was intended;

NOW, THEREFORE, the parties hereto are executing this instrument for the  
purpose of amending said lease so that it will cover only the land described in this  
instrument. Said land being described as follows:

Commence at the Southwest corner of Section 12, Township 22 South, Range  
2 West, and run East along the South boundary line of said Section a  
distance of 2080 feet to a point on the Southeast right-of-way line of  
State Highway #25; thence run Northeasterly along said right-of-way line  
a distance of 350 feet to the point of beginning; thence turn an angle  
of 90° to the right and run a distance of 125 feet to a point; thence  
turn an angle of 90° to the left and run a distance of 200 feet to a  
point; thence turn an angle of 90° to the left and run a distance of 125  
feet to a point on the said Southeast right-of-way line of State Highway  
#25; thence run Southwesterly along said right-of-way line a distance of  
200 feet to the point of beginning.

Said parcel of land is lying in the SE $\frac{1}{4}$  of SW $\frac{1}{4}$ , Section 12, Township 22  
South, Range 2 West, and contains 0.57 acres, more or less. Situated  
in Shelby County, Alabama.
