AMENDMENT TO FINAL DECREE GRANTED IN
THIS CAUSE ON THE 12th DAY OF
APRIL, 1971

THIS CAUSE, coming on to be heard on the 19th day of April, 1971, upon the request of attorney of record, George A. Mitchell, to correct a typographical error in said Final Decree granted in this cause on the 12th day of April, 1971, said typographical error being in the description of property set out in Paragraph 1 of said Final Decree. In lieu of the description shown in said Final Decree, the Court substitutes the following description:

Commence at the Northwest corner of Section 20 Township 22, Range 2 West, thence run South along the West section line of said Section 20, to the South side of the Spring Branch gravel road for a point of beginning, thence continue south along said West boundary line of said Section 20 1320 feet, thence Southeasterly and parallel with or following the curvature of the Spring Branch gravel road 700 feet, thence North and parallel with the West boundary line of said Section 20 approximately 1320 feet to the South side of the Spring Branch gravel road, thence Northwesterly along the South side of the Spring Branch gravel road 700 feet to the point of beginning. Containing 20 acres more or less. All located in the Northwest Quarter of Section 20, Township 22, Range 2 West, Shelby County, Alabama. Mining and mineral rights reserved.

The only change made in this Decree is in the first line of the property description, showing Section 20 instead of Section 29, which may have corrected itself in the third line of the description which designates Section 20. However, the Court is of the opinion
