KNOW ALL MEN BY THESE PRESENTS,

That in consideration of One DOLLARS
and other good and valuable consideration

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,
G. T. Kirkpatrick and wife, Elsie M. Kirkpatrick

(herein referred to as grantors) do grant, bargain, sell and convey unto

Melvin Wayne Beavers and Patricia Ann Beavers

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor
of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated
in Shelby County, Alabama to-wit:

Commence at the northwest corner of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 23, Township 20 South, Range 3 West, run thence in an easterly direction along the north line of said quarter-section for a distance of 74.70 feet; thence turn an angle to the right of 83 deg. 40 min. and run in a southerly direction for a distance of 556.99 feet; thence turn an angle to the left of 90 deg. and in an easterly direction for a distance of 20 feet to the point of beginning; from the point of beginning thus obtained, thence continue along last described course for a distance of 175 feet; thence turn an angle of 90 deg. to the right and run in a southerly direction for a distance of 126.49 feet; thence turn an angle to the right of 76 deg. 33 min. 15 sec. and run in a southwesterly direction for a distance of 143.25 feet to the point of beginning of a curve to the right (said curve having a central angle of 103 deg. 26 min. 45 sec. and a radius of 25 feet); thence along the arc of said curve to the right for a distance of 45.13 feet to the end of said curve; thence along the tangent if extended to said curve run in a northerly direction for a distance of 136.65 feet to the point of beginning.
