My name is Annie Lacey McIntosh. I am 79 years of age. I am a daughter of D. B. Lacey, also known as Daniel Boone Lacey, and Virginia Lacey. I still live on the old D. B. Lacey home place in Shelby County and I am familiar with the hereinafter described land and the persons in possession of it through all the years. Said land being described as follows:

The South 312 yards of the SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 9, Township 21, South, Range 3 West, excepting highway right-of-way; situated in Shelby County, Alabama.

There has been called to my attention a deed made in 1885 from William D. Lacey and wife, Phoebie E. Lacey; John M. Lacey, George T. Harrison and wife, M. A. Harrison; and E. P. Lacey to Ann A. Lacey; Kate Lacey; Emma Lacey; Daniel B. Lacey, James W. Lacey; and Cora M. Lacey; and Martha Lacey, which deed is recorded in Deed Book 9, page 103 in the Probate Office of Shelby County, Alabama, and covers the West  $\frac{1}{2}$  of SW $\frac{1}{4}$  of said Section 9 and other lands. There has also been called to my attention a deed made on January 17, 1925 by Kate Lacey; Emma Lacey; D. B. Lacey and Virginia E. Lacey to Cora Harris covering the above described land. I am familiar with the grantors and grantees in said deed. In fact, I am a daughter of D. B. Lacey and his wife as mentioned above. I know as grantees and grantors the persons named/in said deed made in 1885 were the sole heirs of J. P. Lacey. I also know that James W. Lacey and Martha Lacey died without having married and Ann A. Lacey mentioned in said deed was the wife of John M. Lacey and she never remarried after his death. Affiant further says that the Cora M. Lacey mentioned in said deed in 1885 was one and the same as Cora Harris, to whom said land was conveyed to in 1925 as mentioned above. Affiant further says that the persons shown as grantees in the deed dated in 1885 had all died except those named in the deed made in 1925 as mentioned above and Daniel B. Lacey has been dead since 1959.
