

The E's of the SE's of the SE's of Section 36, Township 20, Range 3 West.



Actually, up until about three years ago about ten acres of the above described property was in cultivation and was farmed and cultivated each year by tenants of the undersigned including Shorty Oden otherwise known as Oscar Oden, and for 15 years prior to the time Oscar Oden cultivated said lane the same was rented to a negro man who cultivated the same for about 15 years. Sims recorded in Deed Book 73, page 246, all in the Probate Records of Shelby County, Alabama.
