STATE OF ALABAMA Shelby County KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, _____ ___ and wife _____ County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be see below _____ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to see below _foot right-of-way acress our lands, said right-of-way herein conveyed being more particulary described as follows, to-wit: And as shown on the right-of-way map of Project NGP1-145 as recorded in the office of the Judge of Probate of Shelby County.

Commence at the northeast corner of the SW4 of SE4, Section 13, T 22 S, R 1 W and run southerly a distance of 429.8 feet to a point on the sub-tangent line of Project CP1-145 at Station 339+21.5; thence turn an angle of 83001' to the right and run along said sub-tangent line a distance of 236.1 feet to a point on centerline of said project at P. C. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or tructures from the above described right-of-way.
