## RIGHT-OF-WAY DEED FOR PUBLIC ROAD

County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be see below feet in width on side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a see below foot right-of-way across our lands, said right-of-way herein conveyed being more particulary described as follows, to-wit: And as shown on the right-of-way map of Project No CP2-11 as recorded

in the office of the Judge of Probate of Shelby County. PARCEL I. Begin at the southeast corner of the NE% of SE%, Sec. 19, T 22 S, R 1 W and run north along the east boundary of said quarter quarter section and crossing centerling of Project CP2-111 at Sta. 192+30 a distance of 97.0 feet to a point on the northeast 40' right of way line of maid project; thence run N 46°02'W along said northeast 40' right of way line a distance of 1020.0' to a point 40' right of P.C. Sta. 202+88.6; thence run northwesterly along said northeast 40' right of way line along a curve to the right (concave northeasterly) and hawing a radius of 1869.86' a distance of 800.1' to a point 40' right of P. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for purpose of moving grantor's buildings and/or structures from the above described right-of-way.
